CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that PATHFINDER EXPLORATION CORPORATION, having an office and place of business at 255 Glendale Avenue, Suite 26, Sparks, Nevada 89431, has located the

lode mining claim this BW 13 day of 16th April, 1992, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a east direction and 1490 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To locate this claim begin at BM 5636, dated 1937, inscribed GWM 7, and located within the SW1/4 Section 28, T.26 N., R.50 E., Mt. Diablo Meridian and bear south 11500 feet and east 3290 feet, to the northeast corner of this claim.

The location monument, corners and side centers are wood posts, set one foot in the ground or mound of stones. The location and markings on each corner or side center are more particularly described as follows:

Thence, 600 feet south to Post No. 2, the Southeast Corner BW 13 - 2  
Thence, 750 feet west to Post No. 3, the South End Center BW 13 - 3  
Thence, 750 feet west to Post No. 4, the Southwest Corner BW 13 - 4  
Thence, 600 feet north to Post No. 5, the Northwest Corner BW 13 - 5  
Thence, 750 feet east to Post No. 6, the North End Center BW 13 - 6  
Thence, 750 feet east to Post No. 1, the Northeast Corner BW 13 - 1  
the point of beginning.

The monumentation and marking of the corners was completed by the 30th day of April, 1992.
