CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that PATHFINDER EXPLORATION CORPORATION, having an office and place of business at 255 Glendale Avenue, Suite 26, Sparks, Nevada 89431, has located the

lode mining claim this BW 33 15th day of April, 1992, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To locate this claim begin at BM 5636, dated 1937, inscribed GWM 7, and located within the SW1/4 Section 28, T.26 N., R.50 E., Mt. Diablo Meridian and bear south 3400 feet and east 290 feet, to the northeast corner of this claim.

The general course of strike of the vein or lode as near as may be determined is north and south.

The claim is located in the: NE 1/4 Section , Twp. 26 North, Range 50 East.
SE 1/4 Section , Twp. 26 North, Range 50 East.
NW 1/4 section 33, Twp. 26 North, Range 50 East.
SW 1/4 Section 33, Twp. 26 North, Range 50 East.
Mt. Diablo Meridian, Unknown Mining District, Eureka County, Nevada.

The location work consisted of making a mining claim map as provided in Nevada Revised Statutes 517.040. Two copies of the map are filed in the records of Eureka County, Nevada.

The location monument, corners and side centers are wood posts, set one foot in the ground or mound of stones. The location and markings on each corner or side center are more particularly described as follows:

Beginning at the northeast corner post No. 1,
Thence, 750 feet south to Post No. 2, the East Side Center BW 33 - 2
Thence, 750 feet south to Post No. 3, the Southeast Corner BW 33 - 3
Thence, 600 feet west to Post No. 4, the Southwest Corner BW 33 - 4
Thence, 750 feet north to Post No. 5, the West Side Center BW 33 - 5
Thence, 750 feet north to Post No. 6, the Northwest Corner BW 33 - 6
Thence, 600 feet east to Post No. 1, the Northeast Corner BW 33 - 1
the point of beginning.

The monumentation and marking of the corners was completed by the 30th day of April, 1992.
