QUITCLAIM DEED AND RELEASE OF OIL AND GAS LEASES

Numerous oil and gas leases ("ORIGINAL LEASES") covering certain lands were issued by Southern Pacific Land Company to Sun Exploration and Production Company and Reading and Bates Petroleum Co. effective December 1, 1982 and shown on Exhibit A attached hereto and made a part hereof.

Southern Pacific Land Company and Bravo Oil Company, successor in interest to Southern Pacific Land Company on deeded lands, (hereinafter referred to individually and collectively as "Lessors"), issued substitute leases ("SUBSTITUTE LEASES") to Sun Exploration and Production Company, Reading and Bates Petroleum Co. and Santa Fe Energy Company combining certain railroad lands contained in and issued as replacements for the "ORIGINAL LEASES", which "SUBSTITUTE LEASES" cover certain lands shown on Exhibit B attached hereto and made a part hereof.

Sun Operating Limited Partnership By Oryx Energy Company Its Managing General Partner transferred its interest in the oil and gas leases, other leases, licenses and orders to Foreland Corporation by Assignment, Conveyance, and Bill of Sale recorded at Book 217, Page 378 of the Records of Eureka County and at Book 737, Page 504 of the Records of Elko County.

RAMCO-NYL 1987 Limited Partnership and RB Operating Company transferred their interests in the oil and gas leases, other leases, licenses and orders to Foreland Corporation by Assignment, Conveyance, and Bill of Sale recorded at Book 217, Page 382 of the Records of Eureka County and at Book 737, Page 508 of the Records of Elko County.

Under said oil and gas leases, lessees, successors or assigns (hereinafter referred to individually and collectively as "Lessee") are required to fulfill certain obligations including, but not limited to a "continuous drilling obligation" (hereinafter referred to as the "Obligation"). As outlined in Section 4 of said leases, said Obligation requires the drilling of wells within a given time interval.

As of the 14th day of May, 1991, under the terms of said leases as recited above, Lessees failed to maintain and meet the Obligation required by the leases. Under Section 21 of said leases, upon termination of the lease, Lessees are required to surrender possession thereof to the Lessor.

SANTA FE ENERGY RESOURCES, INC, and SANTA FE ENERGY OPERATING PARTNERS, L.P., successors in interest to SANTA FE ENERGY COMPANY, INC., 5201 Truxton Avenue, Bakersfield, CA 93309, and FORELAND CORPORATION, 1104 Country Hills Drive, Suite 307, Ogden, UT 84401, as Lessees, hereby release, relinquish, quitclaim and surrender to the Lessor, SOUTHERN PACIFIC LAND COMPANY, its successors and assigns, all of their right, title, and interest in and to those Oil and Gas Leases shown in Exhibits A and B.
