CERTIFICATE OF LOCATION

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The discovery monument is located approximately 2310 feet in a N56°15'W direction from the southeast corner of section 8 T28N, R49E MDM.

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5 x 3.5 inch wooden posts, native timber, or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
