The claim is 1300 feet long and 600 feet wide, and 1250 feet is claimed in a northerly direction and 50 feet in a southerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the north to the south.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by scribing on metal tag attached to post

Corner No. 5 is a 4x4 wooden post marked E side center MJC #7

Corner No. 6 is a 4x4 wooden post marked SE corner MJC #7

The monumentation and marking of the corners was completed by the 12<sup>th</sup> day of July, 1992.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
