**MEMORANDUM OF ASSIGNMENT AND ROYALTY AGREEMENT  
BETWEEN  
SILVER EAGLE RESOURCES LTD.  
AND  
INDEPENDENCE MINING COMPANY INC.**

NOTICE IS HEREBY GIVEN that **SILVER EAGLE RESOURCES LTD.**, a British Columbia corporation, and **SILVER EAGLE GOLD, INC.**, a Nevada corporation (hereinafter collectively referred to as "SILVER EAGLE") and **INDEPENDENCE MINING COMPANY INC.**, a Delaware corporation, (hereinafter referred to as "IMC") have entered into an Assignment and Royalty Agreement dated as of August 5, 1992, (hereinafter referred to as the "Agreement") covering certain unpatented mining claims located in Eureka County, State of Nevada, more particularly described in Exhibit A attached hereto and made a part hereof (hereinafter referred to as the "Property").

Said Agreement, in consideration of the payments, reserved royalty and other covenants and agreements set forth therein, provides that **SILVER EAGLE** has assigned to **IMC**, that certain unrecorded January 20, 1992 Mining Lease Agreement between Jon P. and Margaret C. Broderick and Silver Eagle Resources Ltd. and Silver Eagle Gold, Inc., for the exclusive purpose of exploring, prospecting for and developing all metals, ores, minerals, mineral substances and materials of all kinds from the Property.

The term of said Agreement commenced on the date thereof and shall continue for a period of ten (10) years. IMC has the right at any time to terminate said Agreement on thirty (30) days' notice in writing to SILVER EAGLE.

Any assignment by SILVER EAGLE of any interest in the Agreement or Property shall be subject and subordinate to the other rights and interests of IMC under said Agreement.

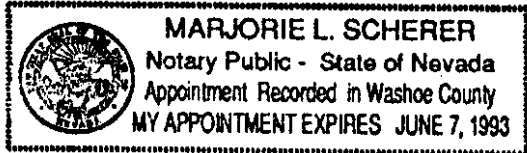

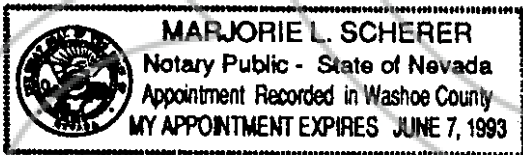
