CERTIFICATE OF RELOCATION
State of Nevada

The undersigned Ruby Hill Mining Company, a Nevada corporation, whose mailing address is 545 North Woodlawn, Wichita, Kansas, 67208, certifies that it has located the MOON lode mining claim, more particularly described below. The date of location is the 30th day of June, 1992.

The number of linear feet claimed in length along the course of the vein, each way from the point of discovery, is 400 feet in an S 60 deg. 33' W direction and 1100 feet in a N 60 deg. 33' E direction. The width claimed on each side of the center of the vein is 300 feet. The general course of the lode or vein, as near as may be, is Northeast and Southwest.

This lode mining claim is located in the SE/4 of Section 16, T. 19 N, R. 53 E, M.D.B.&M., Eureka County, Nevada, and is described by metes and bounds as follows:

Thence N 13 deg. 55 min. E 739.6 feet to Corner No. 1,

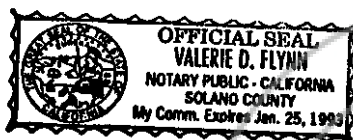
