CERTIFICATE OF RELOCATION

The undersigned Ruby Hill Mining Company, a Nevada corporation, whose mailing address is 545 North Woodlawn, Wichita, Kansas, 67208, certifies that it has located the ANN 14 lode mining claim, more particularly described below. The date of location is the 30th day of June, 1992.

The number of linear feet claimed in length along the course of the vein, each way from the point of discovery, is 50 feet in an North direction and 1450 feet in a South direction. The width claimed on each side of the center of the vein is 300 feet. The general course of the lode or vein, as near as may be, is North and South.
