

QUITCLAIM DEED

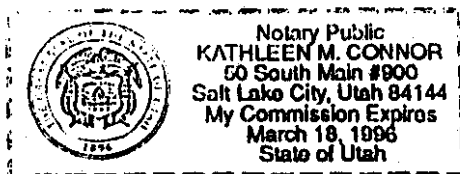
