No. 6: <u>W Side Center</u>	<u>W Side Ctr PHC 35</u>	<u>3"x5' capped, non-perforated PVC pipe</u>

As erected on the ground, each side center or corner monument is marked as described above by scribed metal tag (e.g. metal tags, paint on posts).
