NOTICE OF NON-RESPONSIBILITY

Notice is hereby given that GENERAL MINERAL DEVELOPMENT COMPANY, a Nevada limited partnership having a mailing address of P.O. Box 11856, Reno, Nevada 89510 ("GMDC") is the owner of that certain property located in Eureka County, Nevada more particularly described in Exhibit A attached hereto ("GMDC Claims").

Homestake Mining Company of California, a California corporation authorized to conduct business in Nevada ("Homestake"), is the lessee of the GMDC Claims under the terms of a lease dated August 1, 1992, a Short Form of which has been recorded in Eureka County ("Lease").

Under the terms of the lease Homestake has the exclusive right to conduct exploration, development and mining operations on the GMDC Claims. GMDC will not be responsible for any supplies, services, labor or material furnished to Homestake in connection with its operations on the GMDC Claims, nor for any personal injury or property damage arising out of Homestake's operation while the Lease is in effect.

(ii) GMDC shall not be responsible for any construction, alteration or repair of any building, structure or other improvements placed upon the real property or constructed on all or any portion of the real property, whether directly or indirectly, at the instance of any person or entity acting under or by virtue of any agreement with or at the instance of Homestake.


