SUMMARY REPORT

August 19, 1992

This detailed report and accompanying geologic map is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the STAG #1-#91 (STAG #33-#36 and STAG #48 as amended) group of lode mining claims situated in the Mineral Hill Mining District of Eureka County in the State of Nevada. The claim notices are recorded in the records of the Eureka County Recorder in Eureka, Nevada and in the BLM mining records in Reno, Nevada. The BLM serial numbers for the subject claims are NMC 163380, NMC 244521-NMC 244524, NMC 163385-NMC 163421, NMC 167191-NMC 167195, and NMC 163422-NMC 163465. This report and the accompanying geologic map are the result of a portion of the assessment work for the assessment year ended September 1, 1992 on the aforementioned claims.

The work consisted of both reconnaissance and detailed geologic mapping of a portion of the southeastern and most of the western claims in the claim block to further evaluate the discovery of valuable mineral deposits located thereon (particularly their relationship to jasperoids and jasperoidized limestones) to assist in further planning for exploration and development work. The work was performed in September, 1991 and early August, 1992 by William D. Collins of 20802 Pleasant Park Rd., Conifer, Colorado 80433, the locator/owner of the claims and a geologist of 37 years experience with a B. Sc. degree in Geological Engineering obtained from the University of Idaho in 1955. The cost and/or value of the geologic mapping and associated work exceeded \$9100.00 and was borne by William D. Collins, the locator/owner of the STAG claim group.


The results of the geologic mapping are shown on the accompanying geologic map entitled "Partial Geologic Map, STAG Lode Claim Group" updated on August 18, 1992.
