

CERTIFICATE OF LOCATION  
LODE MINING CLAIM

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The monument of location is 1900 feet southerly and 1250 feet

westerly from the NE corner of Section 19, T 26 N, Range 53 E.

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5" x 3.5" wooden posts, native timber, at least 3 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location.
