

CERTIFICATE OF LOCATION

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The monument of location is 4900 feet southerly and 1200 feet

westerly from the NE corner of Section 19, T. 26 N, Range 53 E.

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5" x 3.5" wooden posts, native timber, at least 3 inch diameter PVC pipe or rock monuments.
