The undersigned certifies as follows:

4. The general course of the lode or vein is north and south.

5. The locator claims 1490 feet in a north direction and 10 feet in a south direction from the location monument at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.

The Northeast Corner (Monument #1) is approximately 3000 feet south and 2940 feet west from the Northeast corner of Section 4, T. 35 N., R. 48 E., M.D.P.M., an official corner of the Public Land Survey. 7. The position of each corner of the mining claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner or side line center monument are as follows:

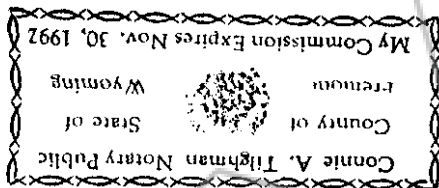
