

STATEMENT OF LOCATION

LODE CLAIM

The undersigned certifies as follows:

1. The name of the locator is WESTERN STATES MINERALS CORP. whose address is 4975 Van Gordon Street, Wheat Ridge, Colorado 80033.

2. On the 14th day of August, 1992, pursuant to the mining laws of the United States and the State of Nevada, the locator located and claimed, and hereby locates and claims, the lode mining claim called the AU 31 mining claim (the "Claim")

3. The claim is located in the Unknown mining district, in Eureka County, Nevada, in the following quarter section(s).

NE 1/4 of Sec. 4, T. 35 N., R. 48 E.; SE 1/4 of Sec. 4, T. 35 N., R. 48 E.; SW 1/4 of Sec. 4, T. 35 N., R. 48 E.; NW 1/4 of Sec. 4, T. 35 N., R. 48 E.; NE 1/4 of Sec. 5, T. 35 N., R. 48 E.; SE 1/4 of Sec. 5, T. 35 N., R. 48 E.; SW 1/4 of Sec. 5, T. 35 N., R. 48 E.; NW 1/4 of Sec. 5, T. 35 N., R. 48 E.

4. The general course of the lode or vein is north and south

5. The locator claims 10 feet in a north direction and 1490 feet in a south direction from the location monument at which the notice of location is posted, together with 300 feet in width on each side of the center of the vein or lode.

6. The Northeast Corner (Monument #1) is approximately 1500 feet south and 1140 feet west from the Northeast corner of Section 4, T. 35 N., R. 48 E., M.D.P.M., an official corner of the Public Land Survey.

7. The position of each corner of the mining claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner or side line center monument are as follows:

8. As erected on the ground, each corner and side line center monument consists of a wood post, 3/4 inches in diameter by 4 feet in length, set one foot in the ground and marked as described above.

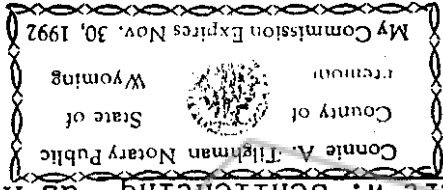
