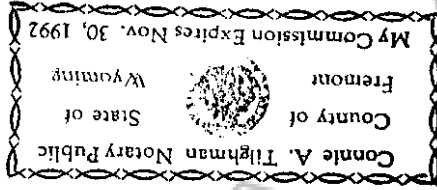

9. The monumentation and marking of the monuments on the ground were completed within sixty (60) days from the date of posting the Notice of Location. The work of location consisted of making and recording of duplicate claim maps filed herein as provided by NRS 517.040.

8. As erected on the ground, each corner, and side line center monument consists of a wood post, 3/4 inches in diameter by 4 feet in length, set one foot in the ground and marked as described above.

7. The position of each corner of the mining claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner or side line center monument are as follows:

6. The Northeast Corner (Monument #1) is approximately 5340 feet north and 3540 feet west from the Southeast corner of Section 10, T. 35 N., R. 48 E., M.D.P.M., an official corner of the Public Land Survey.

5. The locator claims 1490 feet in a north direction and 10 feet in a south direction from the location monument at which the Notice of Location is posted, together with 800 feet in width on each side of the center of the vein or lode.

4. The general course of the lode or vein is north and south.
