

**CERTIFICATE OF LOCATION**

The undersigned certifies as follows:

1. The name of the locator is WESTERN STATES MINERALS CORP. whose address is 4975 Van Gordon Street, Wheat Ridge, Colorado 80033

2. On the 16th day of August, 1992, pursuant to the mining laws of the United States and the State of Nevada, the locator located and claimed, and hereby locates and claims, the lode mining claim called the AU 164 mining claim (the "Claim")

5. The Northeast Corner (Monument #1) is approximately 1520 feet south and 4150 feet east from the Northeast corner of the Public Land Survey. T. 35 N., R. 48 E., M.D.P.M., an official corner of the Public Land Survey.

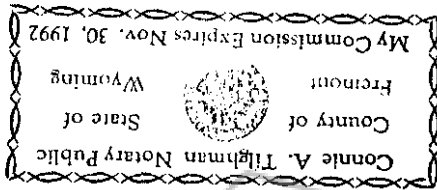
