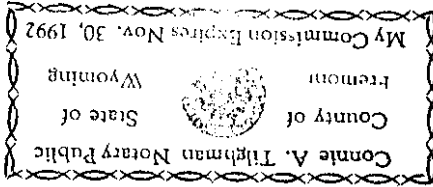

9. The monumentation and marking of the monuments on the ground were completed within sixty (60) days from the date of posting the Notice of Location. The work of location consisted of making and recording of duplicate claim maps filed herein as provided by NRS 517.040.

8. As erected on the ground, each corner and side line center monument consists of a wood post, 3 1/2 inches in diameter by 4 feet in length, set one foot in the ground and marked as described above.

6. The Northeast Corner (Monument #1) is approximately 2350 feet north and 1450 feet east from the southwest corner of Section 24, T. 35 N., R. 48 E., M.D.P.M., an official corner of the Public Land Survey.
