

SPECIAL WARRANTY DEED

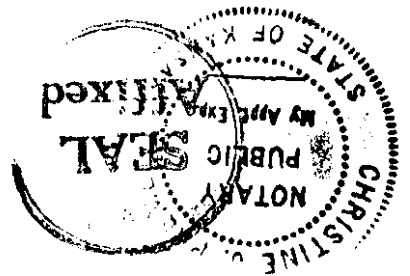
