

# Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 20 feet is claimed in a North direction and 1480 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by an Aluminum Tag.

To tie this claim to the Public Survey, begin at the Northwest corner, Section 20, Township 36N, Range 48E, Mount Diablo P.M., bear SOUTH feet, and 1200 feet, and East, 2340 feet to the northeast corner of this claim.

The description of each corner is as follows:

- Corner No. 1 is a 4"x4" wood post
- Corner No. 2 is a 4"x4" wood post
- Corner No. 3 is a 4"x4" wood post
- Corner No. 4 is a 4"x4" wood post
- Corner No. 5 is a 4"x4" wood post
- Corner No. 6 is a 4"x4" wood post

The monumentation and marking of the corners was completed by the 10th day of September, 1992.
