

MEMORANDUM OF NEW EQUIPMENT MASTER SUBLEASE

Notice is hereby given that Barrick Financeco Inc., a Delaware corporation, whose address is 24 Hazelton Avenue, Toronto, Ontario M5R 2E2 (the "Sublessor"), and Barrick Goldstrike Mines Inc., a Colorado corporation whose address is at the mine site, 27 miles north of Carlin, Nevada 89822 (the "Sublessee") have entered into a New Equipment Master Sublease (the "Agreement") dated as of the 1st day of December, 1992, with respect to certain plant, machinery and equipment.

Upon the acquisition of the Equipment by Barrick Capital Corporation (the "Owner"), the Owner and the Sublessor shall execute and enter into a lease covering each item of equipment acquired by the Owner pursuant to that certain Limited Agency Agreement. Thereafter, the Sublessor and the Sublessee shall execute and enter into a sublease covering that equipment acquired by the Owner. Each sublease describing the equipment affected by it, the term of the sublease and the rent, shall be recorded hereafter. Each sublease shall be subject to the terms set forth in the relevant sublease as well as the terms set forth in the Agreement.

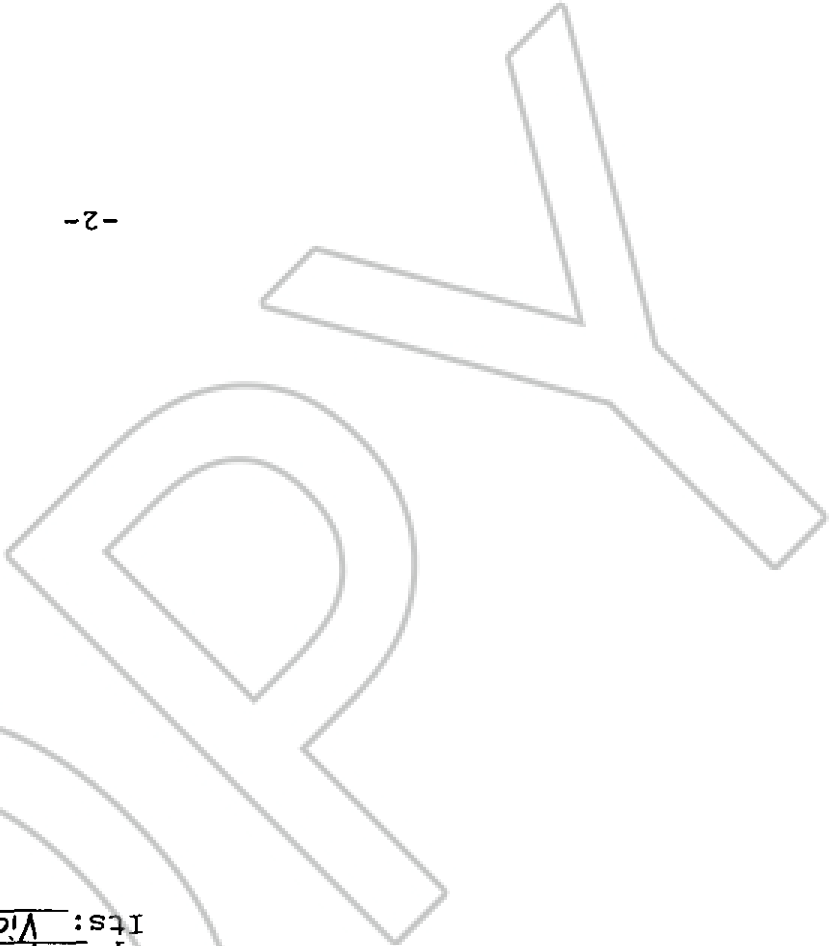
