

**CERTIFICATE OF LOCATION

Thence due west	600	feet to the Northwest	corner;
Thence due south	750	feet to the West	side center;
Thence due south	750	feet to the Southwest	corner;
Thence due east	300	feet to the North	end center.

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The monument of location is 3700 feet southerly and 1250 feet

westerly from the NE corner of Section 35; T. 27 N.; Range 52 E.

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5" x 3.5" wooden posts, native timber, at least 3 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
