

CERTIFICATE OF LOCATION
LODE MINING CLAIM

That on the 3rd day of September, 1992, the above lode mining claim was duly located in the Mineral Hill Mining District, EUREKA County, Nevada.

The locator hereby claims 1475 feet in a southerly direction and 25 feet in northerly direction from the location monument and 300 feet on each side of said lode or vein, the general course of this claim is North-South.

Thence due west	600	feet to the Northeast corner;
Thence due south	750	feet to the Northwest corner;
Thence due south	750	feet to the West side center;
Thence due south	750	feet to the Southwest corner;
Thence due east	300	feet to the North end center.

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The monument of location is 3650 feet southerly and 650 feet westerly from the NE corner of Section 35, T. 27 N, Range 52 E.

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5" x 3.5" wooden posts, native timber, at least 3 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
