

NOTICE OF LIEN CLAIM

NOTICE IS HEREBY GIVEN:

1. That NCI BUILDING SYSTEMS, INC., hereby claims a mechanic's lien pursuant to the provisions of N.R.S. 108.221, et seq., laws of the State of Nevada, in the amount of TWENTY THREE THOUSAND ONE HUNDRED THIRTY SEVEN DOLLARS and 13/100 (\$23,137.13), on the real property and improvements located on Newmont Gold Co. property 27 miles North of Carlin, Nevada in Eureka County at the bio-leach plant of the North Area mining property near truck shop No. 4.

2. The owner or reputed owner of the above-described property is Newmont Gold Co., whose address is Carlin, Nevada.

3. This lien is claimed for material supplied for a pre-engineered steel building and components for the bio-leach plant at the above address.

statutory interest on the amount of this lien claim and costs incurred in perfecting this lien

claim.

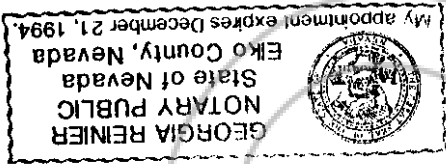
