

NOTICE OF LIEN CLAIM

NOTICE IS HEREBY GIVEN:

1. That TRAMMELS, INC., a Nevada corporation, hereby claims a mechanic's lien pursuant to the provisions of NRS 108.221, et seq., laws of the State of Nevada, in the amount of TWO HUNDRED SEVENTY EIGHT THOUSAND ONE HUNDRED NINETY and 11/100ths DOLLARS (\$278,190.11), on the real property and improvements located at the Newmont Gold Company Gold Quarry Site and the facilities in the South leach areas at said site, approximately six miles north of Carlin, Eureka County, Nevada, generally located in Townships 33 and 34 North and Ranges 51 and 52 East.

2. The name of the owner or reputed owner of the above described property is Newmont Gold Company, whose address is six miles north of Carlin, Nevada.
3. This lien is claimed for material and labor for work performed on the property and improvements described in paragraph 1, above. Said work consisted principally of the following:

- (a) construction of a barren solution sump with structural concrete, piping, structural steel and electrical fixtures;
- (b) furnishing and installing piping and electrical components to retrofit the existing pregnant solution sump and discharge piping;
- (c) construction of a complete pregnant solution sump including intake, discharge piping, structural steel and electrical components;
- (d) completion of floating pump barge; and

(e) construction of permanent truck scales.

4. That said labor and materials were supplied at the express direction

and order of the owner, Newmont Gold Company, through its manager, Bechtel Corporation, pursuant to Newmont Gold Company Construction Contract, No. 21777-LP-03, dated June 15, 1992. Payment was to be made in accordance with the terms and conditions of the aforesaid Contract.

5. Ninety (90) days have not elapsed since the completion of the work

or improvements on the property described above.

6. That the claimant herein is entitled to a reasonable attorney's fee,

statutory interest on the amount of this lien claim, and costs incurred in perfecting this lien

claim.

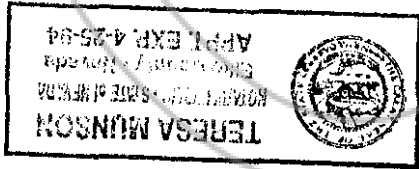
