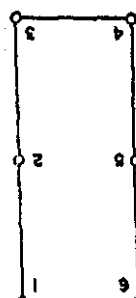
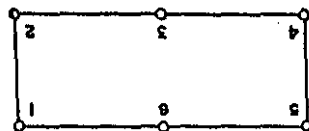

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ROVR 17 Lode Mining Claim on this 23rd day of October, 1992, situated in the Mining District, Eureka County, Nevada.

Said Claim is located in the NE(SE)(NW)(SW) (Quarter) Section(s) 7(6)(8)(5), Township 35 North, Range 51 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

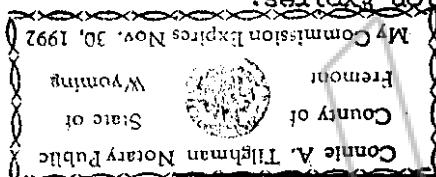
