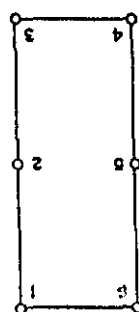
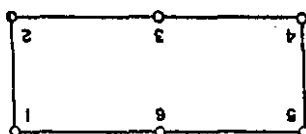

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ROVR 19 Lode Mining Claim on this 23rd day of October, 1992, situated in the Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW)(SE) (Quarter) Section(s) 6(31)(31), Township 35 N.(36 N.), Range 51 E.(51 E.), Mt. Diablo Mer., and is more particularly described as follows, to wit:

the point of beginning and all monuments being 3 1/2" X 3 1/2" X 4' wood posts

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in an east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west

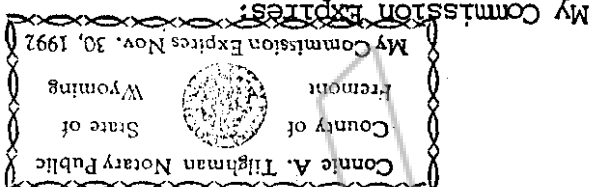
