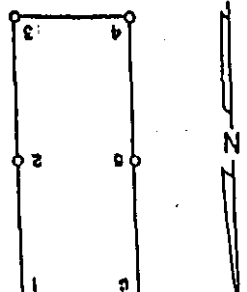
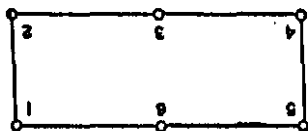

CERTIFICATE OF LOCATION - NEVADA

The general course of the vein or lode is east and west

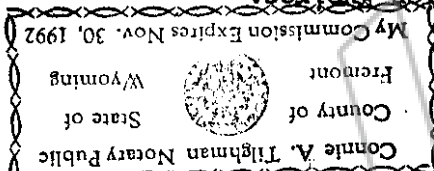
