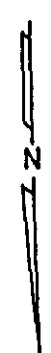
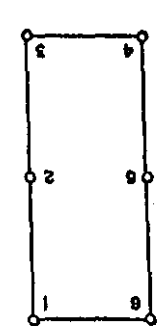
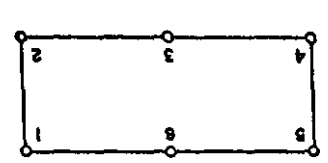

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ROVR 38 Mining Claim on this 23rd day of October, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(SE) (Quarter) Section(s) 34(34) Township 36(36) North, Range 50(50) East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Then, 750	feet in a south	direction to Post No. 2, marked - ROVR 38 -2
Then, 750	feet in a south	direction to Post No. 3, marked - ROVR 38 -3
Then, 600	feet in a west	direction to Post No. 4, marked - ROVR 38 -4
Then, 750	feet in a north	direction to Post No. 5, marked - ROVR 38 -5
Then, 750	feet in a north	direction to Post No. 6, marked - ROVR 38 -6
Then, 600	feet in a east	direction to Post No. 1, marked - ROVR 38 -1

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a north direction and 10 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
