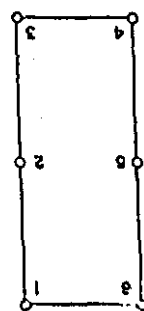
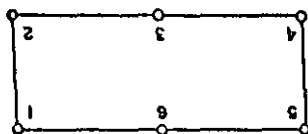

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the BLEU 12 Lode Mining Claim on this 24th day of October, 1992, situated in the Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW) (Quarter) Section(s) 22(22), Township 35 North, Range 50 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 600 feet in a south	direction to Post No. 2, marked - BLEU 12 -2
Thence, 750 feet in a west	direction to Post No. 3, marked - BLEU 12 -3
Thence, 750 feet in a west	direction to Post No. 4, marked - BLEU 12 -4
Thence, 600 feet in a north	direction to Post No. 5, marked - BLEU 12 -5
Thence, 750 feet in a east	direction to Post No. 6, marked - BLEU 12 -6
Thence, 750 feet in a east	direction to Post No. 1, marked - BLEU 12 -1

the point of beginning and all monuments being 3 1/2" X 3 1/2" X 4' wood posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in an east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.

To tie this claim to the Public Survey, begin at the southwest corner, Section 22, Township 35 N., Range 50 E., Mt. Diablo Mer., and bear north, 2350 feet and east, 2900 feet to the northeast corner of this claim.

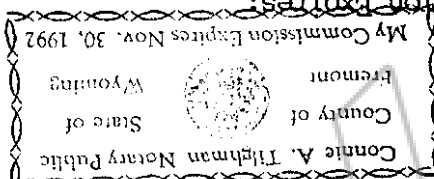
