

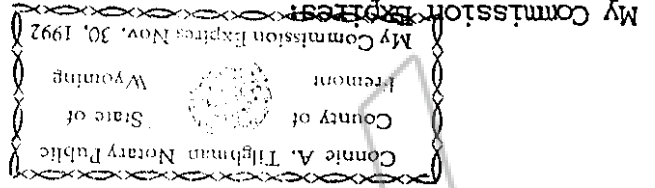

The work of location consisted of making the maps as provided in NRS 517.040. Dated October 26 A.D., 1992, and filed in duplicate.

To tie this claim to the Public Survey, begin at the southwest corner, Section 22, Township 35 N., Range 50 E., Mt. Diablo Mer., and bear north 1150 feet and east 2900 feet to the northeast corner of this claim.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in an east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.
