CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the NOIR 21 Lode Mining Claim on this 25th day of October, 1992, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW)(NE)(NW) (Quarter) Section(s) 26(26)(35)(35), Township 35 North, Range 50 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

the point of beginning and all monuments being 3½" X 3½" X 4' wood posts

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in an east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.

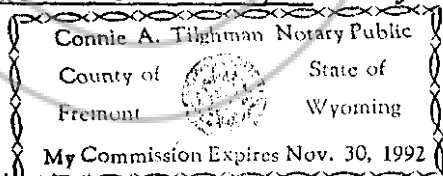
