CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the NOIR 29 Lode Mining Claim on this 26th day of October, 1992, situated in the Unknown Mining District, Eureka County, Nevada.
