CERTIFICATE OF LOCATION - NEVADA

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1190 feet in an east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
