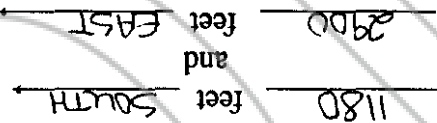

- SW 1/4 of Section \_\_\_\_\_ Township 34 N., Range 50 E.

Mount Diablo Base Line and Meridian, Eureka County, Nevada.

To tie this claim to the public survey, begin at the N 1/4 corner of Section 34, T. 34 N., R. 50 E., MDB&M, and travel:



to the northeast corner of the claim.

The claim is 1450 feet long and 600 feet wide, such that 1430 feet is claimed in an East direction and 20 feet is claimed in a West direction from the location monument, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the claim is East to West.

The boundaries of this claim are monumented with 4 inch by 4 inch by 4 1/2 foot long wooden posts. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

To locate the monuments, begin at the northeast corner of the claim and travel:

- 600 feet South to the southeast corner, thence
- 725 feet West to the south side-center, thence
- 725 feet West to the southwest corner, thence
- 600 feet North to the northwest corner, thence
- 725 feet East to the north side-center, thence
- 725 feet East to the northeast corner of the claim.

The location work included the making of a claim map as provided in NRS 517.040, a copy of which is filed with the county recorder.
