CERTIFICATE OF LOCATION

The undersigned hereby certifies that he, on behalf of NEWMONT GOLD COMPANY, has caused to be located the SHOT 4 Lode Mining Claim in the SW¹/₄ of Section 34, Township 34 North, Range 51 East, M.D.M., in Eureka County, Nevada, on the 27th day of October, 1992.

No. 6: W Center (Witness Corner)	W Center - SHOT 4	4" X 4" WOOD POST
