The claim is approximately 1450 feet long and 590 feet wide, such that 1440 feet is claimed in a EASTWARDLY direction, and 10 feet in an WESTWARDLY direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 295 feet on each side of the monument of location and center line of the Claim. The general course of the lode or being is EAST and WEST.
