The general course of the vein or lode is north and south

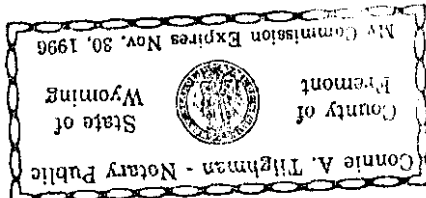
