

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HAWK 8 Lode Mining Claim on this 3rd day of November, 1992, situated in the Mining District, Eureka County, Nevada. Unknown

Said Claim is located in the NW(SW) (Quarter) Section(s) 29(29), Township 36 North, Range 51 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a south direction to Post No. 2, marked - HAWK 8 -2	750	feet in a south
Thence, 750 feet in a south direction to Post No. 3, marked - HAWK 8 -3	750	feet in a south
Thence, 600 feet in a west direction to Post No. 4, marked - HAWK 8 -4	600	feet in a west
Thence, 750 feet in a north direction to Post No. 5, marked - HAWK 8 -5	750	feet in a north
Thence, 750 feet in a north direction to Post No. 6, marked - HAWK 8 -6	750	feet in a north
Thence, 600 feet in a east direction to Post No. 1, marked - HAWK 8 -1	600	feet in a east

the point of beginning and all monuments being 3 1/2" X 3 1/2" X 4' wood

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a north direction and 10 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south

The work of location consisted of making the maps as provided in NRS 517.040. Dated November 24 A.D., 1992, and filed in duplicate.

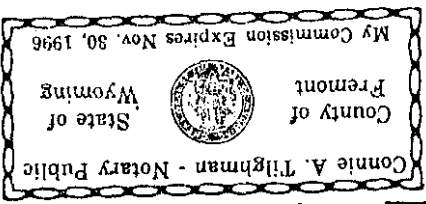
