

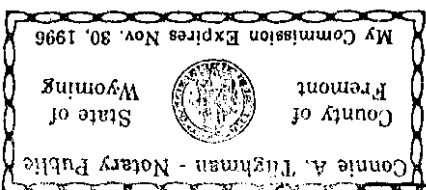

The work of location consisted of making the maps as provided in NRS 517.040. Dated November 24 A.D., 1992, and filed in duplicate.

To tie this claim to the Public Survey, begin at the southwest corner, Section 21, Township 36 N., Range 51 E., Mt. Diablo Mer., and bear south 2320 feet and west 1200 feet to the northeast corner of this claim.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a north direction and 10 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.
