CERTIFICATION OF LOCATION OF LODE MINING CLAIM

The undersigned corporation hereby certifies that it has located the

Towship 35 North, Range 48 East, Mount Diablo Base and
Meridian, in the Unknown Mining District, County of
Eureka, State of Nevada.

The claim is 1500 feet in length and 600 feet in width, and
20 feet is claimed in a West direction and 1480 feet
in a East direction from the location monument upon which the
Notice of Location is posted, together with 300 feet on each side of
the center of the claim. The general course of the lode deposit and premises
is from the East to the West

The N.E. Corner is approximately 4150 feet
North and 300 feet East from the S.E. corner of
Section 16, T. 35 N.R. 48 E., M.D.B.M. an official corner of the Public
Land Survey.

The position of each corner of this claim is shown on the mining claim
map recorded herewith. The number, position and markings on each corner
and side center monument is as follows:

marked as described above with a tag affixed to the monument post. The
monumentations and marking of the above described corners and side line
centers on the ground was completed within 60 days from the date of posting
and the notice of location; and the location work consisted of making and
recording of duplicate claim maps and payment of the fees prescribed by NRS
517.040.
