The claim is 1500 feet in length and 600 feet in width, and
20 feet is claimed in a East direction and 1480 feet

in a West direction from the location monument upon which the
Notice of Location is posted, together with 300 feet on each side of

the center of the claim. The general course of the lode deposit and premises
is from the East to the West

The NE Corner is approximately 2850 feet
North and 1200 feet West from the SE corner of

Section 36, T. 35 N.R. 48 E., M.D.B.M. an official corner of the Public
Land Survey.

recording of duplicate claim maps and payment of the fees prescribed by NRS
517.040.
