The undersigned corporation hereby certifies that it has located the lode mining claim in section 15, Township 35 North, Range 48 East, Mount Diablo Base and Meridian, in the Unknown Mining District, County of Eureka, State of Nevada. The claim is 1500 feet in length and 600 feet in width, and 20 feet is claimed in a West direction and 1480 feet in a East direction from the location monument upon which the Notice of Location is posted, together with 300 feet on each side of the center of the claim.
