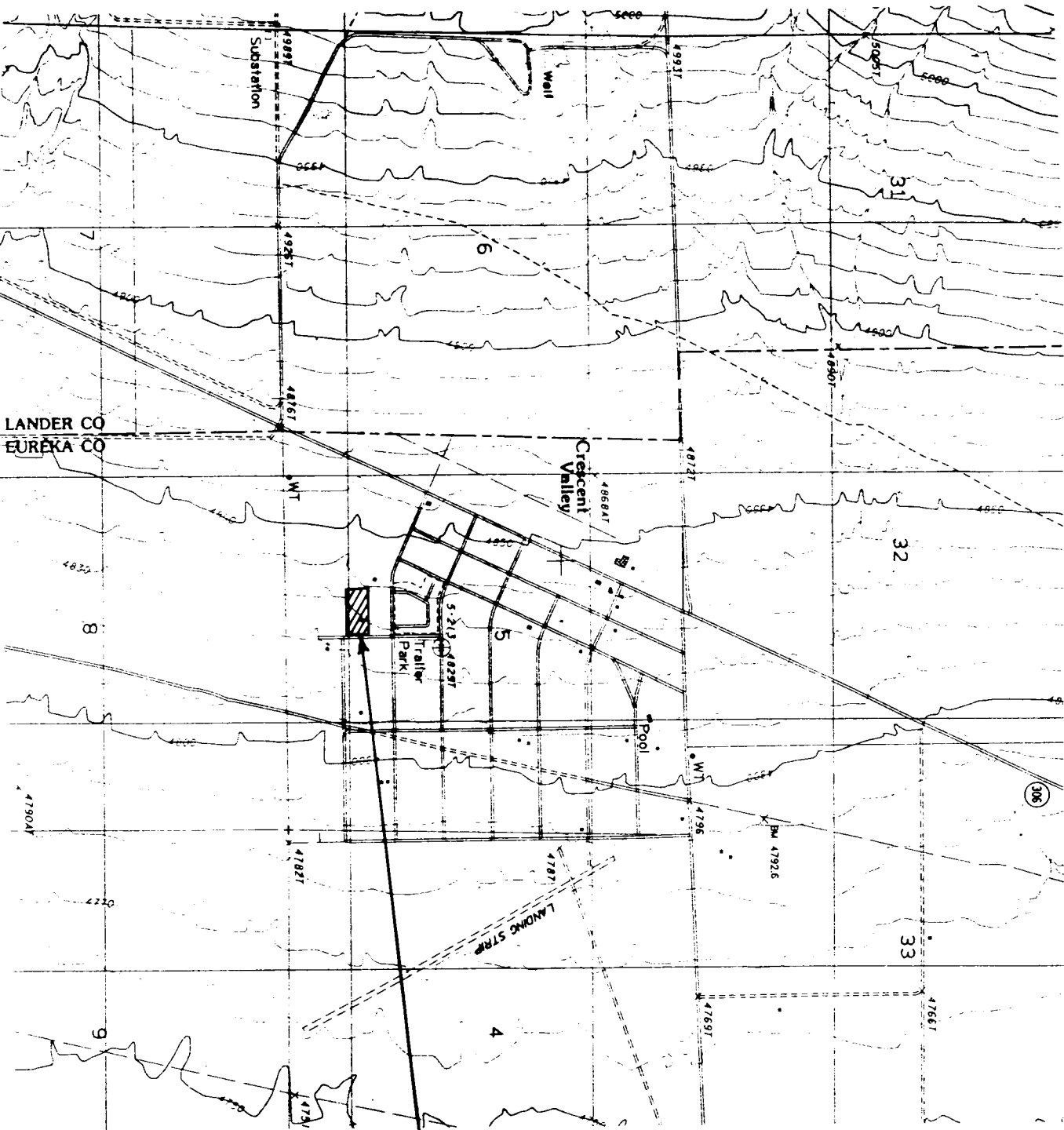

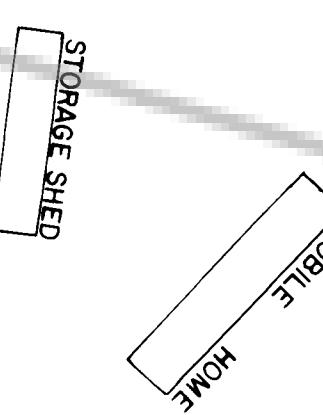

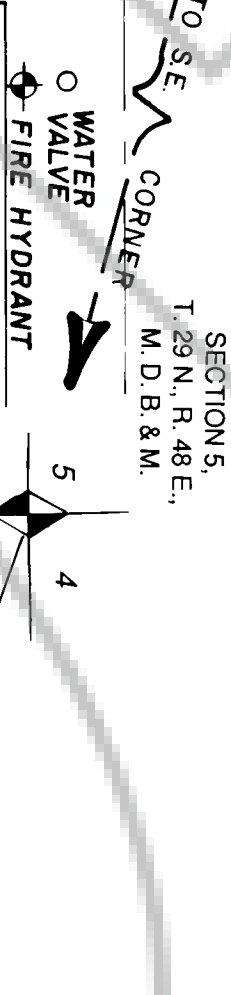
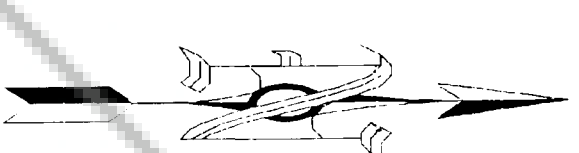
PARCEL 2
