To tie this claim to the public survey, begin at the northeast corner of section 11, T 19 N, R 53 E, Mount Diablo Base Line and Meridian, and travel

5400 feet north  
and  
5900 feet east

to the northeast corner of this claim.

The claim is 1500 feet long and 600 feet wide, such that 1480 feet is claimed in an east direction and 20 feet is claimed in a west direction from the location monument, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the claim is from east to west.

The boundaries of this claim are monumented with 4" x 4" wooden posts four foot long. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

To locate the monuments, begin at the northeast corner of the claim and travel

600 feet south to the southeast corner, thence  
750 feet west to the south side center, thence  
750 feet west to the southwest corner, thence  
600 feet north to the northwest corner, thence  
750 feet east to the north side center, thence  
750 feet east to the northeast corner of the claim.

The location work consisted of making a claim map as provided in RS 27-203, a copy of which is filed with the County Recorder. Dated this 31<sup>st</sup> day of January, 1993.
