3 costs of suit in the amount of ONE HUNDRED SEVENTY TWO and 00/100ths

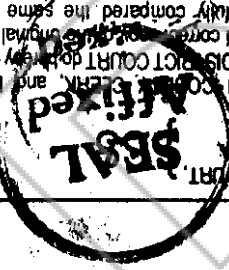
