CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the

lode mining claim this 4th day of March, 1993, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in N55°E direction and 1490 feet in a S55°W direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To tie this claim to the Public Survey, Begin at the Northeast Corner, Section 28, T. 20 N., R. 52 E., Mt. Diablo P.M., and bear S 55° W 7030 feet, and S 35° E 15210 feet, to the northeast corner of this claim.

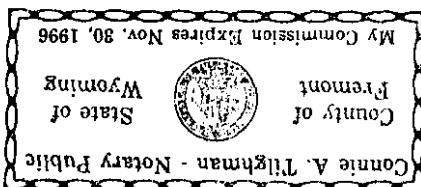
Thence, 600 feet S35°E to Post No. 2, the SE Corner

Thence, 750 feet N55°E to Post No. 6, the N Side Center
Thence, 750 feet N55°E to Post No. 1, the NE Corner
