CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the

lode mining claim this 7th day of March, 1993, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 685 feet in N55°E direction and 815 feet in a S55°W direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To tie this claim to the Public Survey, Begin at the Northeast Corner, Section 28, T. 20 N., R. 52 E., Mt. Diablo P.M., and bear S 55° W 4030 feet, and S 35° E 18210 feet, to the northeast corner of this claim.

The monumentation and marking of the corners was completed by the 12th day of March, 1993.

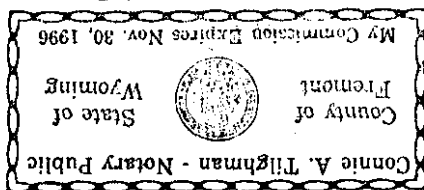
