The Claim is approximately 1500 feet long and 600 feet wide, such that 100 feet is claimed in a NORTHERLY direction and 1400 feet in an SOUTHERLY direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the North to the South direction.

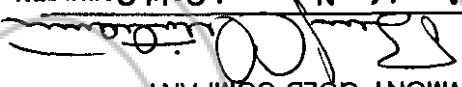
The number, location and markings on each side center or corner monument is as follows:

No. 3: ES Center	ES Center - MOLE 2	4" X 4" WOOD POST
No. 4: SE Corner	SE Corner - MOLE 2	4" X 4" WOOD POST
No. 5: SW Corner	WC-SW Corner - MOLE 2	4" X 4" WOOD POST
No. 6: WS Center	WS Center - MOLE 2	4" X 4" WOOD POST

As erected on the ground, each side center or corner monument is marked as described above by marked aluminum tag. The above indicated witness corner (WC) is particularly depicted on the Claim map.

The work of location consisted of making a claim map as provided in N.R.S. 517.040.
